- 1. Board meeting minutes of 2/28/12 and 3/8/12 were read. Motion to accept the minutes of 2/28/12 and 3/8/12 as read was seconded and passed.

We will have to move in <u>and</u> rehearse that day. Discussed performing GM two days later on Thurs (open), Fri, Sat, Sun, and then Wed, Thurs, Fri, and Sat (strike). This is not cast in stone may change with discussion. Discussed other venues which do not seem possible at this short notice. Motion to accept the Dairy's schedule of 2 weeks for the first show of next season was seconded and passed.
- 4. Order of the rest of the season:

Woman of No Importance – move in 11/25/12, strike 12/15/12 Caesar and Cleopatra – move in 2/17/13, strike 3/9/13 Henry V – move in 5/19/13, strike 6/8/13 Motion to do these shows in the above order was seconded and passed.

The business of the annual meeting will be the paying of dues, election of the board, and play submissions. We will have the Midsummer's Party immediately following the annual meeting we will be sending out reminders.
- 6. Discussed ticket prices, etc. of Fast, Loud and Overplayed, which is a fundraiser. A ticket will be a \$40 suggested donation. It will be tax deductible. Joe I. will talk to various restaurants, etc. to get donated refreshments, hors d'oeuvres, drinks, and the like. Richard will direct FLO. Motion to let Richard decide how he wants to cast FLO was seconded and passed. Rehearsals will probably begin soon after Merry Wives closes.
- 7. Board meeting to discuss FLO details, picking other directors, storage issues, and season tickets will be a lunch meeting on Saturday, May 12 at 11:00 at the Bell's. Once again, let us know what you are bringing.
